Frequently Asked Questions (FAQs)

1. What is the objective of the Sentencing Conference?

The Sentencing Conference was first mooted in 2011 when greater potential was seen for a discussion that started out amongst various domestic stakeholders. The primary objective of the Conference series is to raise general awareness among judges, prosecutors, lawyers, law enforcement officers, academics and other stakeholders in the criminal justice system of sentencing issues and perspectives, which will provide the catalyst for further debate and study to enhance the fairness and effectiveness of the criminal justice system.

The first Sentencing Conference, themed "Trends, Tools and Technology", was held in 2014 and saw more than 300 participants from across six countries.

The Sentencing Conference 2017, themed "Review, Rehabilitation and Reintegration", is the second in the series.

The Sentencing Conference 2022, themed "Sentencing Frameworks – Instructive, Communicative and Consistent Outcomes", is the third in the series.

2. What will the Conference cover?

The Conference will feature distinguished local and international speakers who will explore the following topics over six sessions:

- a. The evolution of sentencing in Singapore, with a focus on sentencing trends, principles and frameworks as discerned from Supreme Court jurisprudence between 2017 to 2022.
- b. An overview of how the Probation and Community Rehabilitation Service and Ministry of Social and Family Development facilitate pathways to desistance through effective community rehabilitation.
- c. The principles of mental health interventions that an offender with mental illness would receive and undergo in Singapore, including forensic psychiatric evaluation and risk assessment in the pre-sentencing phase.
- d. Sentencing options for special classes of offenders, such as youth offenders or offenders with mental conditions who commit minor offences, as well as the rehabilitative processes that apply post-sentence.

- e. An overview of the Singapore Prison Service's rehabilitation approach and the evidence-based models that inform its rehabilitation work.
- f. Current technological tools in sentencing and the tension between the publication of data to educate the public.

4. What is the Sentencing Advisory Panel?

Following the announcement by Minister for Home Affairs and Minister for Law K Shanmugam in his Ministerial Statement on the Review of Sentencing Framework for Sexual and Hurt Offences on 5 March 2021 in Parliament, a Sentencing Advisory Panel has been established.

The key function of the Panel is to formulate and publish guidelines on matters relating to sentencing, to promote greater consistency, transparency and public awareness.

The Panel comprises members from the Judiciary, the Ministry of Law, the Ministry of Home Affairs, the Singapore Police Force, the Attorney-General's Chambers, and the Bar.
