The SICC aims to accompany the growth in international transactions and to address the concomitant issues of breach of contract by companies in Asia and beyond. Apart from Singaporean judges, there are 11 foreign judges (including Mr Taniguchi) who preside as judges at the SICC. The judges come from a variety of jurisdictions, including England, America, Australia, Hong Kong, France and Austria among others. Cases that involve contracts that are governed by foreign laws are also handled by the SICC. The SICC differs from the existing private arbitration infrastructure in Singapore in that decisions of the full-time judges at the SICC are publicly rendered and can be appealed upwards to the Singapore Court of Appeal. Mr Taniguchi was previously a member of the appeals board at the dispute resolution body of the World Trade Organization (WTO). In addition to the benefits of swift turnaround and low cost envisioned to be part of the new SICC, Mr Taniguchi also states that "the SICC, as a proper court, will be a welcome and effective new option for Japanese companies, which are traditionally not keen on private arbitration". The SICC is one exemplary manifestation of Singapore's plan to become the legal hub of Asia. Previously, Singapore had also worked actively to attract foreign law firms to its shores. and in particular to have international disputes resolved via arbitration in Singapore. MAGNA CARTA

2015 marks the 800th anniversary of the granting of Magna Carta - The Great Charter - by King John at Runnymeade.

Today, we tend to think of *Magna Carta* as a significant foundation document of our civil rights. It is doubtful whether this assessment is historically correct, but because people over the past 400 years have assumed it to be correct, it has virtually become correct.

Professor Les Downer, in his article "Legal History – Is it Human?" (1963) 4 MULR 1 at 5, truly said:

The mediaevalist will deny ... that Magna Carta gave us trial by jury, and he will be right. The modern lawyer-cum-politician will be heard to assert that it did. He too will be right. What is historically a legend has become politically an overpowering reality.

Whether its effect is really legendary or not, it is a most significant document in our constitutional, political, and legal history, and we do well to commemorate its anniversary.

The speech given by the Hon James Spigelman AC QC, in the Banco Court in Sydney during April, commemorating the event, is published in this issue of Journal.

APPOINTMENT OF AUSTRALIAN JURISTS TO THE SINGAPORE INTERNATIONAL COMMERCIAL COURT

In November 2013, the Singapore International Commercial Court Committee, constituted by lawyers practising in Singapore and eminent international lawyers, including the Hon James Spigelman AC QC, former Chief Justice of the Supreme Court of New South Wales and a judge of the Court of Final Appeal of Hong Kong, produced its report on the feasibility of establishing an International Commercial Court in Singapore.

On 5 January 2015, the Singapore International Commercial Court (SICC) was established as a Division of the Singapore High Court, and part of the Supreme Court of Singapore, to facilitate the resolution of complex, trans-national commercial disputes and in response to predicted growth in trade and investment across Asia. The SICC's jurisdiction includes claims of an international and commercial nature where the parties have submitted to the SICC's jurisdiction, and cases transferred from the High Court.

The SICC is constituted by judges of the Singapore High Court, as well as international judges. On 5 January 2015 the Hon Mr Dyson Heydon AC QC, former Justice of the High Court of Australia, the Hon Justice P A Bergin, Chief Judge in Equity of the Supreme Court of New South Wales and the Hon Mr Roger Giles QC, former Judge of Appeal of the New South Wales Court of Appeal, were appointed as International Judges.

The other International Judges who were appointed at the same time are Ms Carolyn Berger, former appellate judge of the Delaware Supreme Court; the Hon Dr Irmgard Griss, Deputy Member of the Austrian Constitutional Court and former President of the Austrian Supreme Court; the Hon Justice Dominique T Hascher of the Supreme Judicial Court in France; Sir Vivian Ramsay, a former judge of the High Court (Queens Bench Division) of England and Wales; the Hon Anselmo Reyes SC, a former judge of the Court of First Instance in Hong Kong; the Rt Hon Sir Bernard Rix, a former Lord Justice of Appeal of the Court of Appeal of England and Wales; Mr Simon Thorley QC, a former Deputy High Court Judge of England and Wales; and Professor Yasuhei Taniguchi, Professor Emeritus at Kyoto University in Japan.
