Established under the auspices of the Supreme Court of Singapore, the Singapore Judicial College (SJC) is dedicated to the training and development of Judges and Judicial Officers (JOs). The SJC consists of a Local and an International Wing and Empirical Judicial Research.





Local Wing

The Local Wing oversees the needs of the Singapore Judiciary, from induction to continuing education, to research and developmental programmes.

International Wing

The International Wing builds on the excellent reputation of Singapore's well-developed legal system to offer Singapore as a forum of judicial training that encompasses induction training, core competencies development (such as judging, judicial ethics, case management, use of technology and judicial administration), recent developments on areas of legal interest and useful interdisciplinary studies.

Empirical Judicial Research

The SJC serves as an Empirical Judicial Research laboratory for innovation in judicial studies and practices. The empirical research will allow new or existing practices in the courts to be tested and validated.

CHIEF JUSTICE'S RESPONSE AT THE

Opening of the Legal Year 2016



"I turn to the Judiciary. At the last Opening of the Legal Year, I stressed the importance of continuing education for our judges. A year later, it is my great pleasure to commend and congratulate the SJC for the tremendous progress that it has already made. It offered more than 40 programmes last year, recording a cumulative attendance exceeding 1,000. The SJC also conducted the inaugural "Judiciary-Wide Induction Programme" for newly appointed Judicial Commissioners and JOs. This was attended by 27 of our colleagues and three judges from overseas.

The SJC also enjoyed notable success in its international programmes. It presented nine courses for foreign judges and these attracted more than 250 participants from over 40 countries across Asia, the Middle-East and the Pacific, including courses that were conducted in Phnom Penh, Yangon, Vientiane, Hanoi and the Solomon Islands. The last of these was a 2-day workshop on eFiling for more than 65 judges, lawyers and court officials.

The excellent work of the SJC in its inaugural year has been captured

in its first Annual Report, which has been made available to you. For the coming year, I have asked the College to focus on enhancing judicial case management skills because robust case management is a critical tool for reducing the costs and time incurred in litigation and we can expect to see this being used to a greater degree. Immediately after these proceedings, we will launch the SJC Business Centre."

FOREWORD FROM THE

Chief Justice



— When we envisioned the SJC, we had high expectations. Two years on, I am heartened that the SJC has not disappointed. The theme of this annual report "Making Our Mark" could not be more appropriate since the SJC has made its presence felt both at home and abroad.

In the 2015 Annual Report, I mentioned the notable achievements of the Singapore Judicial College (SJC) in its first year of operation, and expressed confidence that it would scale even greater heights moving forward. Far from resting on the laurels of its accomplishments, I am heartened that the SJC team is growing in experience and professionalism and forging ahead in the areas of judicial education and empirical judicial research.

On the local front, the SJC offered more than 40 judicial education programmes in 2016. As a result, each of our judges would have attended an average of at least five training sessions during the year. It is critical that the SJC's curricula meet the training needs of our judges. To this end, I am pleased to note that the SJC continues to actively engage our judges in order to ascertain their evolving training needs, understand the challenges faced on the ground and propose new areas of training. Arising from

such feedback, two new areas of focus were added this year, that is, "Technology & Sciences" and "Court Leadership". In 2017, our judges can look forward to programmes on "Judicial Resilience" which will include cognitive dissonance, judicial wellness and cultivating judicial selfdiscipline. With the increasing number of programmes offered, we must build up a pool of trained instructors to support our "Judges to Train Judges" philosophy. I must commend the SJC for having assembled a Basic Judicial Educators' Workshop in February 2016 for interested judges to be exposed to what judicial education is all about. I have no doubt that the wide spectrum of training opportunities available to our judges will raise the bar in the quality of justice delivered.

In the international arena, the SJC continues to make an impact, designing and delivering a total of 14 programmes in 2016 for our global legal fraternity. Since its inception, the SJC has welcomed more than

600 international participants from more than 60 countries to its courses. The programmes funded under the Singapore Cooperation Programme are invariably oversubscribed. Some of our foreign counterparts have also sought the SJC's assistance to run similar programmes in their respective jurisdictions so that more could benefit from the training. One of the aspirations of the SJC is to forge deeper friendships with our foreign counterparts. The International Wing is making positive strides in this regard. This is evident from the signing of a Memorandum of Understanding in March 2016 between the Office of the Judiciary of the Kingdom of Thailand and SJC to advance continuing judicial education opportunities between the two judiciaries.

Even as the SJC continues to reach new milestones in the provision of judicial training both in Singapore and overseas, I am heartened that the empirical judicial research initiative is progressing well. The SJC's Board of Governors has approved seven proposals from the Faculty of Law of the National University of Singapore, School of Law of the Singapore Management University and Family Justice Courts. I look forward to the publication of the first projects which I hope to launch soon. I am most grateful for the strong support from our friends in academia for this important undertaking.

The Local Wing moved up another gear in 2016. More high impact and skills-based judicial training workshops and forums emphasising 'hands-on' learning were added for the benefit of our judges. They include judgment writing, basic Judicial Educators' training, and effective engagement of Litigants-In-Person, techniques of case management, understanding the sciences and exercising court leadership. For selected equipping sessions, we have implemented enhanced learning analysis by studying participants' feedback obtained six months after the training. The focus is on whether our judges have had the opportunity to apply the skills learnt and the corresponding assessment of their effectiveness.



When to Recuse?

Justice Vinodh Coomaraswamy, Supreme Court




Cognitive Studies Affecting Decision Making

A total of 50 JOs from the Supreme Court, State Courts and FJC participated in the 1-day workshop to acquire skills to more effectively manage LIPs with personality disorders at hearings as well as respond to their written correspondence. Two psychiatrists from IMH spoke on "Identifying, and Effective Engaging/Disengaging LIPs with Personality Disorders" and "Techniques and Best Practices of Handling Correspondence with Querulous LIPs".

Besides briefings, consultation and discussion, skills-based activities were weaved into the 1-day programme consisting of (a) role play for our participants to engage and manage difficult LIPs and (b) analysis and responding to a demanding LIP's correspondence, with the IMH psychiatrists providing valuable inputs on the appropriateness and efficacy in engaging LIPs, especially those with personality disorders.

The day's learning ended with an enlightening and entertaining panel discussion on "Tried and Tested Ways to Effectively Manage Challenging LIPs" led by Justice Chan Seng Onn and moderated by Judicial Commissioner Foo Chee Hock (Dean, SJC).


Training for the Guangdong Judicial Group

Training for the Omani Judiciary

Court Dispute Resolution: A One-Stop Judicial Training on Alternative Dispute Resolution

23 – 25 February 2016 | Supreme Court, Singapore

The SJC conducted a 3-day workshop titled "Court Dispute Resolution: A One-Stop Judicial Training on Alternative Dispute Resolution". It was organised with the Chartered Institute of Arbitrators (CIArb), an initiative under the auspices of the ASEAN Chief Justices' Meeting Working Committee on Judicial Training and was sponsored by the Singapore Cooperation Programme and the Supreme Court of Singapore.

The workshop gave 18 ASEAN judges an overview of the comprehensive suite of court-initiated dispute resolution channels to manage different needs. It included mediation and international arbitration, featuring instructors from the Singapore Mediation Centre (SMC) and CIArb, as well as learning journeys to the Supreme Court, State Courts, SMC, Singapore International Mediation Centre, Singapore International Arbitration Centre, and Maxwell Chambers.











Strategies of Case Management: Challenges, Solutions and Innovation

4 – 8 April 2016 | Rendezvous Hotel, Singapore

In conjunction with the Ministry of Foreign Affairs' Singapore Cooperation Programme, a total of 31 Judges, Judicial Officers (JOs), and government officials from 27 countries attended the 5–day programme which examined the various approaches to case management and the International Framework for Court Excellence. In addition to the interactive 'classroom' sessions, participants went on learning journeys to the Supreme Court, State Courts and FJC to experience first-hand deployment of case management strategies.

This 5-day workshop "End-to-End Court Technology" was held in conjunction with the Singapore Cooperation Programme. A total of 28 Judges, JOs, and government officials from 25 countries were introduced to the systems that have made the Singapore Judiciary and legal profession more integrated, effective, efficient, user-centric and 'paper-less'. In addition to the classroom sessions, learning journeys to the courts and vendors' premises were woven into the curriculum.







Initiative for ASEAN Integration (IAI): International Framework for Court Excellence (IFCE) Workshops

26 – 29 April 2016 | Phnom Penh, Cambodia 17 – 20 May 2016 | Yangon, Myanmar 31 May – 3 June 2016 | Hanoi, Vietnam 27 – 30 June 2016 | Vientiane, Lao PDR

The SJC conducted 4-day workshops on the IFCE for judges and justice-related officials in several ASEAN countries. In all, more than 130 judges, court administrators and officials were trained on the IFCE over the four workshops held in Cambodia, Myanmar, Vietnam, and Lao PDR. The participants found the IFCE extremely helpful for them to work on improving the performance of the courts. Instead of reinventing the wheel, judges and justice-related officials can attempt to use the IFCE checklist to identify areas for improvement, close the gaps, and map out action plans for the courthouses they evaluate.

Besides the benefits of adopting the IFCE, participants also learnt from the experience of the Singapore Judiciary in implementing the various aspects of the IFCE in enhancing the administration of justice.

Parliamentary Law, Rules and Practices

1 – 4 August 2016 | Vientiane, Lao PDR 31 October – 3 November 2016 | Yangon, Myanmar

In conjunction with the Singapore Cooperation Programme, under the auspices of the IAI, the SJC conducted 4-day workshops on Singapore "Parliamentary Law, Rules and Practices".

A total of 49 participants attended the training. Participants learnt about the organisational structure, key office holders, functions, sittings, the legislative process and select committees of the Singapore Parliament. Participants also had an opportunity to navigate Singapore's Statutes Online and Parliamentary Reports.

The content delivered provided the participants with a platform to interact on Singapore's experience which may generate new ideas that may serve as possible areas of reform in the participant's country. At the end of the workshops, participants mapped a strategic plan for reform to help them adopt, adapt and generate ideas when they are required to put up recommendations for changes to their Parliaments.







Judiciary-Wide Induction Programme

11 – 14 October 2016 | Supreme Court, Singapore

Facilitated by instructors that include members of the Supreme Court Bench and high-level Singapore government officials, the SJC conducted its annual 4-day "Judiciary-Wide Induction Programme" covering a wide range of topics relevant to the work of a judge.

In addition to newly appointed Judicial Commissioners and JOs of Singapore, the programme was attended by foreign judges from Bangladesh, Thailand, Taiwan, Japan, and United Arab Emirates (Dubai).

Court Excellence and Court Dispute Resolution: A Tale of Two Workshops

The SJC, in conjunction with the Singapore Ministry of Law, conducted a 4-day workshop to introduce participants to two critical areas: (i) Court Excellence; and (ii) Court Dispute Resolution. A total of 30 participants were trained.

In addition to introducing participants to the International Framework for Court Excellence, participants acquired the basic knowledge and understanding of how Court Dispute Resolution can be implemented in their courthouses. They also learnt the function of a Judge-Mediator through role play.







Judicial Ethics and Court Leadership

The SJC conducted a 2-day workshop for 10 judges from the Supreme Judiciary Council of the State of Qatar. Judicial Commissioner Foo Chee Hock (Dean, SJC) and District Judge Tan Boon Heng (Executive Director, SJC) shared with the participants universal principles of judicial conduct and ethics, and the application thereof to specific scenarios. In addition, they were introduced to Category 1 of the International Framework for Court Excellence on Court Leadership. Finally, the participants were briefed on Singapore's experience in implementing eFiling and the work of the Singapore Mediation Centre.







ABOUT THE

Empirical Judicial Research Programme

An important and unique dimension of the SJC is the Empirical Judicial Research initiative. This will serve as a test bed for innovation in judicial studies, practices and policies. Probably the first of its kind in Asia, this initiative pushes the frontiers for local judicial research to incorporate quantitative analysis. The research findings and recommendations are expected to bear a special significance, not only to Singapore, but potentially other parts of Asia and the Middle-East. New or existing practices in the courts can then be tested and the underlying premises of prevailing policies or practices validated.

To date, seven projects have been approved. The first fruits of this initiative are expected to be published in early 2017.
