  - (c) Trans-national arrival and departure timings should be used to compute the Subsistence Allowance if the witness arrives/departs within 24 hours before/after his court attendance.

7 Court attendance means the presence of a witness in court during any inquiry or trial to (a) await his turn to give evidence or to be identified by other witnesses, (b) give evidence, or (c) in the case of an expert witness, assist counsel when the corresponding expert witness of any other party to the proceedings is giving evidence.

## **Tax Implication of Court Attendance Allowance**

- Court attendance allowance are considered income chargeable to tax, whether the witness carries on a trade, business, profession, vocation or is an employee.
- Court attendance allowance will be withheld for IRAS tax computation. The balance amount, after tax deduction, will then be paid to the witness.
